Sir,

In continuation of this Ministry's letter of even number dated 14.7.2006 on the subject noted above, I am directed to say that an inspection of the college was conducted by Medical Council of India on 22nd May 2007. The Executive Committee of Medical Council of India considered the inspection report in its meeting held on 13th & 14th June 2007 and recommended to the Central Government to renew the permission for the admission of 2nd batch of 100 MBBS students for the academic year 2007-08. Subsequently, an inspection of the college was carried out by Central Team on 13.7.2007 and the college authorities were given an opportunity of personal hearing on 17.8.2007.

In view of the submission/clarification made by the college authorities on the observations of Central Team at the personal hearing, I am directed to convey the approval of the Central Government for renewal of permission for admission of 2nd batch of 100 (one hundred only) MBBS students for the academic year 2007-08 at Rohilkhand Medical College & Hospital, Pilibhit By-pass Road, Bareilly, Uttar Pradesh by Rohilkhand Educational Trust. The renewal of permission is, however, subject to the condition that admission process may be completed as per time schedule prescribed in the Regulations of Medical Council of India. Copies of MCI inspection report of May 2007 and Central Team inspection report dated 13.7.2007 are enclosed.
