Sir,

In continuation of this Ministry's letter of even number dated 14.7.2006 and 17.8.2007 on the subject mentioned above, I am directed to say that the inspection of Rohilkhand Medical College & Hospital, Bareilly, Uttar Pradesh was conducted by MCI on 1st & 2nd April 2008, 20th May 2008 and 19th August 2008. The Executive Committee of MCI considered the inspection reports and decided to recommend to the Central Government not to renew the permission for the admission of 3rd batch of 100 MBBS students at Rohilkhand Medical College & Hospital, Bareilly, Uttar Pradesh for the academic year 2008-09.

In view of the directions given by the Hon'ble Supreme Court of India on 22nd September 2008, a central team inspection was conducted on 25.9.2008. The Central Team noted that the adequate facilities are available for the renewal of permission for admission of 3rd batch of 100 (one hundred only) MBBS students for the academic year 2008-09 at Rohilkhand Medical College & Hospital, Bareilly, Uttar Pradesh.

After careful consideration of the MCI inspection reports and central team inspection report, the approval of the Central Government is granted for renewal of permission for admission of 3rd batch of 100 (one hundred only) MBBS students for the academic year 2008-09 at Rohilkhand Medical College & Hospital, Bareilly, Uttar Pradesh. The permission is, however, subject to the condition that admission process may be completed as per time schedule prescribed in the Regulations of Medical Council of India.
